Prof. Godbout's report proposes additional fees such as raising sales taxes, introducing a new tax on books and other goods that aren't currently taxed, increasing daycare fees and electricity bills. All these proposals are regressive – they will impact those who don't have a lot of money the most. The report believes users of public services should pay up front for the services received – instead of the financial burden being shared collectively.

The report also proposes to review many policies, such as tax credits given to large businesses, but only to allow the government to lower these businesses' taxes instead of funding public services and social programs! The report also proposes an increase in the number of income tax brackets, but not in a way that would make the rich pay more, which is one of our core demands.

Last june, Quebec's Finance minister based himself on this report and claimed that income taxes are "the worst form of taxation," a clear sign that this fall's consultations are going to create a heated debate on the way our public services and social programs are funded.

They say they want to reform the tax system in a way that doesn't increase its burden on the economy. But we know the way they want to do this will negatively impact society. If the tax system is going to change, income taxes should not go down - instead, more money needs to go towards public services and social programs. This fall, we need to mobilise to demand wealth be redistributed, and against the regressive taxes and fees that Prof. Godbout and the government believe in.
